The aforesaid subscription was for financing of the acquisition and construction of fixed assets for Gaylin Malaysia and the consideration was funded from the IPO proceeds of the Company.

The aforesaid subscription is not expected to have any material impact on the earnings per share or the net-tangible assets per share of the Company for the current financial year ending 31 March 2014.
